(The brief guidelines given below are only indicative. For detail, the corresponding orders/ notifications issued from time to time must be referred).

- Minimum passing marks : In each Theory Paper 30% in Final Examinations and 40% in aggregate i.e. total of term test and final examinations. Similarly in Practicals and Sessionals 30% in each component separately and 40% in aggregate of both components taken together.
- A candidate shall be awarded :
 - Honours, if he/she secures atleast 70% of the aggregate i.e. 5600 marks or above, (4200 marks or above in case of diploma candidate).
 - First Class, if he / she secures atleast 60% of the aggregate i.e. 4800 to 5599, (3600 marks to 4199 in case of diploma candidate).
 - Second Class, if he/she secures atleast 50% of the aggregate i.e. 4000 marks to 4799, (3000 marks to 3599 in case of diploma candidate).
 - Pass Class, if he / she secures below 4000, (below 3000 marks in case of diploma candidate) subject to fulfillment of condition at point no.1.
- University reserves the right to issue the corrected (Revised) Marks Sheet, if any mistake is found in the original Marks Sheet.
- All court cases shall be subject to the jurisdiction of Rajasthan Technical University headquarters i.e. KOTA and not any other place.
