- 12. You shall be governed by the service rules and conditions, applicable to the said Project, as in force and amended or altered or modified from time to time.
- 13. Accommodation will be provided to you by the Company. Any sort of damage to the rooms provided to you, shall be recovered from your salary at site.
- 14. If you resort to unlawful practices such as go-slow, intermittent stoppage of work, the Company shall be free to make proportionate deductions from your wages apart from taking disciplinary action in that behalf.
- 15. Safety rules are to be followed by you at site. Incase, any penalty is levied on the Company for breaking the safety rules, the same shall be recovered from your salary.
- 16. You are liable to be transferred to any of our other Divisions, work sites, etc. without any additional allowances, remuneration or other benefits.
- 17. You shall keep us informed of any change in your residential address or civil status during the tenure of your training period employment with the Company.
