NOTES

- 1. Year of passing refers to the year of the examination of a session in which the candidate has passed.
- 2. Each subject is allotted a Credit Unit generally equal to its weekly contact hours.
- 3. The percentage marks of a candidate in a subject is multiplied by the Credit Unit for the subject to arrive at the Credit Point in that subject. The aggregate of the Credit Point in all the subjects is the total Credit Point in the Examination, which divided by the total Credit Units of all the subjects of the Examination is the Semester Credit Point Average (SCPA).
- 4. The SCPA of a candidate in each of the eight Semesters of the Course of Study is multiplied by a weightage to arrive at the Total Credit Point Average (TCPA).
- 5. A candidate who has passed all the subjects of all the eight Semesters of the Course of Study will be awarded the following Class :
 - (i) First Class Honours, provided he/she has secured a TCPA of 75 or more, having passed all the subjects of the Examinations of all the eight Semesters of the Course of Study appearing at the Regular Examination only and within four academic years of his/her first admission to the First Semester Course of Study, provided further that, if a candidate fails to appear in a regular Examination only once during his/her entire Course of Study but passes the subjects in the immediately following Supplementary Examination, he/she may be awarded First Class Honours.
 - (ii) First Class, provided he/she has secured a TCPA of 60 or more and is not eligible for First Class Honours.
