Unless extended in writing, this employment will stand automatically terminated at completion of the project or on foreclosure of the Project on the date specified by the client. You undertake not to claim any notice period in any of these situations.
- 3. You are presently assigned at any of our sites located in **Baroda**. However, based on the organizational requirements, the Company may assign you at any of its offices, units or project offices anywhere in India at its discretion.
- 4. You will report to Project In-charge/ Project Coordinator on or before 25-July-2022 (Joining Date) and will follow the instructions given by him or by any person assigned by him from time to time.
- 5. Your Monthly Gross is **Rs. 26,004/- (Rupees Twenty-Six Thousand Four only)** exclusive of benefits such as PF, ESIC. Statutory deductions and PT as applicable as per the government rules.
- 6. All payments shall be subject to applicable taxes.
- 7. You are expected to adhere to the laid down company/ Client HSE policy and guidelines as per IMS standards. Non adherence of the same will invite disciplinary action. Please note the company is governed by POSH guidelines and you are requested to adhere to the same.

- 12. This offer has been made based on the assumption that your credentials are in order. In the event any incidents having any bearing on your credentials come to our notice, the same shall be dealt by the Company at its discretion.
